Course Description:

During your three years in law school you will learn a lot about how to "think like a lawyer," which is a central component of the law school experience. There are, however, many other competencies that are important to legal employers and that are an important part of your professional development. Other competencies that legal employers consider when hiring new attorneys include integrity, honesty, trustworthiness, initiative, strong work ethic, good listening skills, stress management, project management skills, cultural competency, and responsiveness to feedback, to name a few. Through a variety of speakers and panels, this class will introduce you to some of these professional competencies that effective lawyers must possess beyond their technical legal skills. During this course you will also start to draft a plan for using your three years in law school to develop the different competencies that you will need to effectively serve clients and to obtain meaningful employment with your law degree.
